
The Board and REI hope you will find the below news and information to be helpful. Thank you for your time in reading our newsletter and for your cooperation where required.

• Power-washing/painting/staining has been completed in the following areas:

Tucker Street (3-21) and Paulding Terrace. On Sampson Terrace, the power-washing is almost completed and the deck staining/trim painting has begun.

All gas meters 3-84 Tucker Street, Paulding Terrace and Sampson Terrace have been painted, as well as the of the fire hydrants throughout the community.

Power-washing/deck staining/trim painting of the following areas will be completed this year as well - 22 through 84 Tucker Street. The Association will be powering washing and painting the wood components on the mailbox stations on Tucker Street, Sampson and Paulding Terrace.

A notice will be placed on your front door 48 hours before your building and deck are to be power-washed and stained. Please ensure all items are removed from your deck and that your windows are closed. If the items are not removed, the contractor will do their best to move the items around in order to complete your deck. Please note - neither the contractor, Association nor REI will be responsible for any damaged personal property.

- The Timber Oak Board of installation of six speed humps at the May Board of Directors meeting. The six speed humps will be installed along Lawrence Avenue on Monday, July 31<sup>st</sup>; weather permitted. They will be painted the following day on Tuesday, August 1<sup>st</sup>; weather permitted.
- The Board of Directors/Landscaping Committee and REI Property Management have completed inspection of all asphalt/concrete and driveway divider walls. The Association is in process of obtain proposals for the repairs.
- The landscaping inspection has also been completed. All dead bushes/shrubs were removed on July 19<sup>th</sup>. Bartlett Tree will be providing recommendation/proposals regarding unhealty trees. The Lanscapcing Committee will be walking the community with the landscaper to obtain a proposal for fall plantings.



Once proposal are approved, and the work is scheduled, you will receive notification.



The remaining board meeting schedule for 2017 is — Monday, August 28<sup>th</sup>; Monday, September 25<sup>th</sup>; Monday, October 23<sup>rd</sup> and Monday, November 13<sup>th</sup>. The Open Session will begin at <u>7:30 PM</u> in the clubhouse. A standard agenda is attached for your review.

If you would like to be heard, please notify Kelly Montesi so she can place your name on the agenda. To keep these meetings on track, the Board is asking that comments and questions be made before the meeting moves from "requests of owners to speak" to the review of the monthly management status package.

All requests that require Board approval must be submitted to Kelly Montesi at least one week prior to the meeting in order to be included in the board status package. Any material submitted after the deadline may be placed in the following month's status packet for the Board of Directors review.


